

**Cookie POLICY**  
**Stock Company CROCUS INTERNATIONAL (short title SC CROCUS)**  
**Crocus Expo Krasnogorsk subsidiary**

**1. General provisions**

**1.1.** This Cookie Policy (hereinafter referred to as the Policy) applies in addition to the Personal Data Processing Policy of the SC CROCUS Crocus Expo Krasnogorsk subsidiary (hereinafter referred to as Crocus Expo) and applies to Crocus Expo information services.

**1.2.** The Policy describes the types of cookies, the purpose of their use, the procedure for processing and using Crocus Expo data collected during the use by visitors of the Crocus Expo website <https://eng.crocus-expo.ru/> website (hereinafter referred to as the Website), as well as the methods by which you can refuse to process.

**1.3.** When the user starts using the Website the user will be notified of the use of cookies. By continuing to use the website the user gives consent to the use of cookies and to the Policy.

If the user does not give consent to the use of this type of file on the Website the user may set his browser settings accordingly or exit the Website.

If the user wants to disable the use of cookies, the user must go to the settings of his personal computer and disable the use of all types of cookies or enable the warning function when saving them. Continuing to use the Website without changing the cookie settings means the user's consent to the use of cookies and to the Policy.

**2. Cookie definition**

**2.1.** Cookie is a fragment of data sent by the web server and stored on the user's computer, the service header of the HTTP protocol (the term was introduced by Order of the Ministry of Telecom and Mass Communications of Russia dated 15.04.2019 No. 139).

**2.2.** Cookies are small fragments of data that can be stored on the user's computer or other devices when visiting a website, with the help of which the website can distinguish new and old visitors and determine how the Website is used. The cookie can contain information about the user's operating system, browser type, IP address, visited pages of the website, duration of sessions, coordinates of the user's device, language settings and other personal settings of the page and information about the user's navigation in the website.

**3. Purpose of cookie**

**3.1.** Cookies are used to optimize the operation of the Website, to track the user's online activity as well as to customize the content of pages according to the user's preferences, allow the Website to remember information about the pages of the Website visited by the user, the category of interest and the choice made, so that there is no need to re-enter search information.

**4. Cookie control and management**

**4.1.** Most Internet browsers for users are initially configured to automatically accept cookies. The user can change the settings so that the browser blocks cookies or warns you when files of this type will be sent to the device. To manage cookies, the user should refer to the browser

instructions to learn how to adjust or change the browser settings. Disabling cookies can affect the user's Internet experience. If a user uses different devices to view and access the Website (for example, a computer, smartphone, tablet, etc.), they must ensure that each browser on each device is configured according to their cookie preferences.

**4.2.** The Website can be used without cookies. To do this, you need to disable saving cookies, limit their creation to specific websites or set a notification about sending cookies in your browser. The user can also disable cookies from the hard drive of his personal computer (file: "cookie") at any time but in this case the display of pages and the guide to using sites will be limited. Most browsers allow you to control most cookies to varying degrees through browser settings.

## **5. Types of cookie**

### **5.1. Session cookie**

The Website installs session cookie on its visitor's device for temporary use when the user browses the Website. Session cookies are intended to be deleted by the browser when the browser closes. It helps track real-time changes in a user's activity while on the Website and it helps the web pages load faster and makes navigation easy for the user.

### **5.2. Persistent cookie**

Persistent Cookies can be stored on a user's computer or device by the Website and they remain there even after the user has closed the web browser. These cookies are designed to stay active for a longer period of time, typically to remember user preferences or provide personalized experiences during subsequent visits to the same website.

### **5.3. Statistical**

Statistical cookie is beneficial for the Website, in order to make valid reports on the use of their website, what pages are visited, what links are used. The purpose of such cookies is to improve the functions of the Website

### **5.4. Obligatory**

Minimum cookie set, the use of which is necessary for the correct operation of the Website.

## **6. Closing provisions**

**6.1.** The Policy is approved by the order of the Director of the SC CROCUS Crocus Expo Krasnogorsk subsidiary and comes into force from the date of its signing.

**6.2.** The Policy is subject to amendments and additions approved by the order of the Director of the SC CROCUS Crocus Expo Krasnogorsk subsidiary.
